The methodology follow will combine a multi-layered 4 slices approach, including:

1. Theoretical approach to cover the major competences per each module;
2. The adaptive approach to provide the right amount of content considering the level of knowledge per topic by each student (per the table presented in 1.4);
3. A challenge based learning approach in deploying the measures identified and studies in real context.

Regarding the theoretical approach, this is basically the delivering of the major relevant contents per each module, to make prepare and awareness on the topics. The theoretical approach will be integrated with the challenge based learning approach in order to enable the attendants to solve problems they might encounter in practice (problem solving).

To this extent teaching activities will involve officials of the national Data Protection Authorities who will teach the implementation the EU law in their legal system, from their point of view.

In order to practice the technical and organizations skills learned in the courses, a training period (e.g. stage) will be offered to the participant in the National DP Authorities offices or in other public or private

institutions related to data protection, as well as in companies which could have need of the skills produced by the training activities, all in accordance with these partners engagement schemes and at the end courses period (training activities).
